Executive Summary

BCRC Slovakia considers its Business Plan for the 2020 - 2023 as the basic document which could help all relevant stakeholders, including donors, in an improved orientation to knowing the situation and needs in hazardous waste management in the region of the Central and Eastern Europe or in countries with economies in transition (CET). The BCRC Slovakia itself, in addition to the core functions given by the COP 6 Decision, has three main targets of its orientation:

- A. Direct assistance to the CEE region. The centre will continue its assistance to all served countries as it was in previous four years. As there are new vision and problems we would like to focus in relation to served countries in general on:
 - i. Environmentally sound management of selected waste streams in assistance with the relevant legislation preparation and enforcement
 - ii. To support the synergy and cooperation between waste and chemicals management
 - iii. Control system for transboundary movement of hazardous waste and chemicals
- B. The high importance will be given to the close cooperation with BRS secretariat, other regional centres for Basel and Stockholm Convention and familiar multilateral environmental conventions under UN Environemnt.
- C. The BCRC Slovakia will continue in its active participation in different partnership programmes and contact groups with the aim to be direct channel between the region and the convention.

1. Introduction and Background

BCRC Slovakia cooperates with its respective region since 1997. The situation in hazardous waste management is totally changed from that time. The same applies to the BCRC role. The centre fulfils all core functions requested by the COP Decision and provides support in short term and long-term regional activities ad hoc activities. As national priorities of the served countries has changed, the BCRC reflects the new situation. All countries from the region are Parties to the Basel Convention. A half of the region became EU members since 2004 what has an influence upon the regional activities. EU member states are no more eligible for the financial support, but their experts assist to the BCRC as consultants in projects or speakers during regional workshops. Served countries, which are still in a position of "accession" or "pre-accession" to the EU, request from the BCRC assistance

related to harmonisation of the national legislation with the EU legislative framework. Such request is constantly reflected in our activities.

During the last four years (2016-2019) the Centre has actively supported served countries with implementation of the Basel Convention but also with Stockholm and Minamata Conventions via projects and regional workshops/trainings. Most of the regional activities were financed by the UNEP/ European commission and the Slovak Aid programme. BCRC is an active member of many partnership programmes and working groups under umbrella of the Basel Convention. It gives to the centre a good opportunity to give immediate information to the region and to be involved in project activities. Many of our projects were directly connected to testing of the manuals, guidance or fact sheets. We have tested in close cooperation with selected countries two chosen EWG products (fact sheet on e-waste and general manual for policy in the pilot project of the Expert working group on the environmentally sound management under Basel Convection). The BCRC has prepared project proposals for testing a manual on waste prevention and a fact sheet on end-of-life vehicles.

Countries with economies in transition, served by BCRC Slovakia, often often report to our staff insufficiency or lack of professional, institutional and financial capacities to implement all Basel Convention provisions. It is visible in addressing the environmentally sound management issues and also being constantly reflected in national requests regarding the need on strengthening of the transboundary movement of hazardous waste and other waste. During the past four-year period, the BCRC Slovakia provided assistance to served countries on daily a basis and as well as a long-term assistance.

2. Goals and Objectives:

The activities expected to be performed during the next 4-year period are planned at both national and regional levels. It depends on national priorities of the served countries but also on the donor interests and open calls for project proposals. If the previous period was focused mainly on e-waste management (which is still in place and requested), currently we have to focus and prioritize the plastic waste management and household waste, waste prevention and minimization in general and circular economies. The BCRC with its experts will offer to solve the problems mentioned above.

The BCRC is ready to provide assistance via different ways. The BCRC provide technical and professional support in ad hoc daily basis. Another option is organization of a topicdriven meeting or training at regional level with regional attendance or national workshop which give good opportunity for more national relevant stakeholders from different areas. We offer long term projects as a good opportunity in preparation of the strategic programmes and action plans and in preparation, implementation and enforcement of the national legislative framework in hazardous waste management. We have provided our assistance also via organizing of study visits and we would like to continue such practice in upcoming period as well. In addition, countries asked for an expert's mission in their countries.

If we have to summarize the goal in concrete specific targets the Centre has intension to see within region:

- Strengthening in activities related to completing the duties for the national reporting

- Environmentally sound management in requested waste streams
- Strengthening of the control system for the transboundary movement of hazardous waste and chemicals
- Strengthening of the cooperation and coordination among all three MEAs in synergy with the Minamata Convention provisions
- Strengthening of the enforcement capacities to foster effective implementation of the provisions stipulated in relevant MEAs, specifically related to environmentally sound management of hazardous wastes and other wastes and including improvement of the waste management data gathering
- Know-how and continuous testing and piloting of the guidelines, factsheets and draft manuals by the served countries, with the goal on providing recommendations for improvement / modifications
- Improving regional communication and experience exchange, particularly using the EU countries expertise and their applicability to non-EU member countries of the CEE region, particularly using the EU tool TAIEX

Objectives

The main objectives of the proposed Business Plan are:

- To assist CET countries to implement the Basel Convention principles and provisions into national legislation and its enforcement
- To monitor and support the countries in implementing the technical guidelines / manuals developed by BRS and working groups
- To build capacities of the served countries in the fields related to MEAs implementation, including Minamata
- To ensure the regional information exchange to support the effective implementation of the hazardous waste and chemicals Conventions
- To support activities leading to fulfil Basel convention COP adopted decisions
- To support activities leading to the synergy and cooperation process

Based on our experiences we know that we should allocate enough time for the signature and approval of various documents by the national and regional decision makers.

Political and related institutional changes are beyond of our scope of influence. The most of our partners are strong enough to deal with such a kind of problems and we have never had any delay because of this.

The Procurement process in the Slovak republic is very strict and time consuming. We are obliged to go through it, but finally it ensures us that we have decided for the most efficient way in the selection process. The detailed information about the selection process and the legislative framework of the procurement procedure was submitted to the BRS Secretariat in 2018.

The BCRC budget does not unfortunately allow to its staff to attend all relevant meetings and to answer positively to the invitation letters.

The Business Plan/Work Plan
